COMMITTEE DETAILS

1. Introduction:

Everybody is entitled to the basic human rights and liberties. A new comer in One Beat College of Medical Science (OBCMS) can't obviously be denied of all such right & liberties. So, let us welcome the fresher with an open and warm heart and endeavor to make their entry to OBCMS as charming as possible. Towards this end, let us take a pledge to have a totally ragging free OBCMS.

Ragging, which is also known as hazing or fagging in the western world is a punishable offence. According to The U.P. Prohibition of Ragging in Educational Institutions Act, 2010 of The U.P. legislation which is treated as the low of the land for this purpose defines ragging as:

"Ragging" means asking a student to do any act or perform something, causing, inducing, compelling or forcing a student by way of either by words or sign or signal to do any act which detracts from human dignity or violates his person in any way or exposes him to ridicule, intimidating, wrongfully restraining, wrongfully confining and injuring or holding out to him any threat or intimidation, wrongful restraint, wrongful confinement, injury or the use of criminal force.".

The committee constituted by the Hon'ble Supreme Court of India in SLP no 24295 of 2006, popularly known also as "*Raghavan Committee*" declared ragging as a criminal offence and recommended certain measures to curb ragging. Based on these recommendations, Hon'ble Supreme Court of India vides its order dated 16.05.2007 passed an order to eradicate ragging from educational institution of India.

Subsequent to this order, All India Council for Technical Education (AICTE) and Pharmacy Council of India (PCI) took up the matter and issued a notification on 01/07/2000 and 23/05/2012 respectively suggesting measures to eradicate ragging from technical *Institutes of our Country. The complete text of the side notification is reproduced toward* the end of this booklet for the benefit of all concerned. Following these directives, we at OBCMS have adopted a multi- strategy to tackle the menace of ragging.

2. Objectives:

- 2.1. To aware the students of dehumanizing effect of ragging inherent in its perversity.
- 2.2. To keep a continuous watch and vigil over ragging so as to prevent its occurrence and recurrence.
- 2.3. To promptly and stringently deal with the incidents of ragging brought to the notice of the competent authority.
- 3. Anti-ragging Policy: A student who behaves in such a manner that violates the expected standard of the College will undergo investigation and appropriate disciplinary action where necessary. All students are expected to behave in an appropriate manner while on and off the College premises. Students shall grossly be restricted for the following areas:-



3.1. Disturbing / disrupting other students, staff members and faculty members.

- 3.2. Any forms of Ragging
- 3.3. Discrimination
- 3.4. Behavioral Misconduct
- 3.5. Damaging assets of the College.
- 3.6. Violations of this Code of Conduct

4. Composition of Anti-ragging Committee:

- 4.1. Chairperson: The Head of the Institution / Principal shall be the Chairperson of the Committee.
- 4.2. Convener: One of the nominated faculty members shall act as the convener of the committee.

4.3. Members:

- 4.3.1. Representative of Civil Body:
- 4.3.2. Representative of Police Administration:
- 4.3.3. Representative of Non-Government Organization:
- 4.3.4. Representative of Local Media:
- 4.3.5. Representative Faculty: Two to Six faculty members nominated by the Academic Council time to time.
- 4.3.6. Students: Two to Six students nominated by the Academic Council time to time.
- 4.3.7. Supporting Staffs: One to three supporting staffs nominated by Academic Council time to time.

5. Term:

The term of the nominated member shall be THREE years. The term may be extended by the Chairperson, if deemed necessary for smooth function of the Committee.

6. Meeting Frequency & Quorum:

The Convener of the committee is responsible for timely conduct of meetings. The Committee shall meet at least once in every month. More meetings may be conveyed during admission time or whenever it deemed necessary. The Convener shall keep a record of the proceedings of the Committee and to be circulated among all members time to time. Two third members of the Committee shall be a quorum.

7. Duty & Responsibility of the Committee:

- 7.1. To oversee general discipline in the College and assist the Head of the Institution / Principal in ensuring that the College functions smoothly.
- 7.2. To frame draft policies for Code of Conduct for students and offenses thereof.



- 7.3. To review and recommend any necessary change in Conduct rule of the College for students.
- 7.4. To enquire into cases of indiscipline *suo moto*, or on report from any student, staff, teacher etc.
- 7.5. To recommend Head of the Institution / Principal for appointment of Inquiry Committee to investigate any act of indiscipline.
- 7.6. The Committee shall recommend necessary action or punishment to the Head of the Institution / Principal in case a student is found guilty of indiscipline.
